Frequently Asked Questions About Stacia's Consultations

Does Stacia give legal advice during the consultation?

No. A consultation is not the same as an attorney/client relationship. In a consultation, Stacia does not provide legal advice, comment on whether you have a "good case," tell you what you should do, or discuss how the law is likely to apply to your situation. A consultation allows you to discuss your legal issue so that Stacia can determine whether she can help you and, if so, how. It is also for **you** to determine whether you would like to hire her. Communications in a consultation are confidential.

Can Stacia tell me how much hiring an attorney will cost from start to finish?

Usually not. The limited exchange of information in a consultation does not provide a deep enough dive into your legal issue. Stacia's hourly rate is \$275, and any estimates are just educated guesses. Occasionally, Stacia may be able to provide a flat fee quote in the consultation.

Does Stacia offer in-person consultations?

No. Stacia's practice is location independent and paperless. She operates a mobile law firm and virtual office that is heavily reliant on technology. She does not maintain a physical office open to the public. Once hired, meetings occur in private conference rooms at mutually agreed locations. Stacia maximizes client convenience (a reduction in travel time and avoidance of parking fees), maximizes her own efficiency, and minimizes her overhead, resulting in incredibly personalized service at reasonable hourly rates.

What happens after a consultation?

In the consultation, Stacia will tell you whether or not she can help. If she cannot, she will try to provide you with additional useful resources so that you can continue on your search for legal assistance. If she is able to help, she will explain her intake process so that you can decide whether to hire her as your attorney. No attorney/client relationship exists until an attorney/client agreement is signed.
